1) 2023-I – Well Abandonment

On March 14th, 2023, five bids were received in response to 2023-I. All bids were determined to be qualified meeting all of the required specifications. Staff's recommendation to the Board is to award either Newsome Well & Septic the lowest qualified bidder with a timeline of 30 days, or Roundman's Pump Repair the lowest qualified bidder with a timeline of 14 days.

MOTION by Commissioner Williams to award Newsome Well & Septic the lowest qualified bidder with a timeline of 30 days, or Roundman's Pump Repair the lowest qualified bidder with a timeline of 14 days. SECOND by Commissioner Murphy. The motion carried unanimously.

2) Resolution No. 2023R-15 – Request for COPCN – North Florida Regional Medical Center, Inc.

North Florida Regional Medical Center, Inc. requested a COPCN for interfacility transport. This would allow them to pick up patients at Lake City Medical when they are unable to get timely transport for patients going down to North Florida for transfer admission. They will provide an ALS/BLS ambulance because many of these transfers are ALS patients; cardiac, respiratory, etc.

MOTION by Commissioner Williams to approve Resolution No. 2023R-15. SECOND by Commissioner Phillips. The motion carried unanimously.

3) Job Description Revision – Tourist Development Director

Stew Lilker offered comment.

MOTION by Commissioner Murphy to approve revision. SECOND by Commissioner Williams. The motion carried unanimously.

4) Permission to Negotiate - NOAA lease - Franklin St. Tower.

Central communications requested permission to enter into negotiations with the National Oceanic and Atmospheric Administration (NOAA) for Tower Vertical Space and Utilities. NOAA to extend their lease for an additional 5 years on Franklin Street Tower.

MOTION by Commissioner Murphy to Authorize negotiations to extend lease on Franklin Street Tower with NOAA. SECOND by Commissioner Phillips. The motion carried unanimously.

5) Permission to Negotiate – AT&T – Tower Replacement

Central Communications recommended revisions to the AT&T lease of space on the Lulu tower. Upon approval of the revised language, Central communications will finalize funding details with AT&T.

MOTION by Commissioner Murphy to approve lease language as presented. SECOND by Commissioner Hollingsworth. The motion carried unanimously.

6) Permission to Negotiate – T-Mobile/Sprint Communications – Tower Space

Central Communications recommended revisions to the T-Mobile/Sprint Comm lease of tower space. If the revised language is approved, Central Communications will finalize funding details with T-Mobile/SprintComm.

MOTION by Commissioner Williams to approve lease language as presented. SECOND by Commissioner Phillips. The motion carried unanimously.
