# David Kraus County Manager

1) Columbia Youth Football Association – Youth football

The Columbia Youth Football Association requests the County operate the youth football program. Also, utilize the Columbia Youth Football Association as a booster organization supporting a county run program.

MOTION by Commissioner Murphy to, once the budget is presented; fund the necessary money to run the youth association program for the upcoming fall season. SECOND by Commissioner Williams. The motion carried unanimously.

2) Two-Cent Gas Tax Extension - Resolution No. 2023R-24

The County's levy of the two-cent local option gas tax on motor fuel and special fuel sold in the county is scheduled to expire on December 31, 2023. The levy was created in 1986 pursuant to Ordinance No. 86-6, and has been extended three times via Ordinance 89-4, 99-8, and 2008-27. The 2008 extension was for a period of fifteen years.

MOTION by Commissioner Murphy to adopt Resolution No. 2023R-24 of intent to extend the Levy of the two-cent local option gas tax until December 31, 2033. SECOND by Commissioner Williams. The motion carried unanimously.

## 3) Columbia County Subdivision Design/Maintenance Manual

Stew Lilker offered comment.

MOTION by Commissioner Williams to approve Columbia County Design/Maintenance manual. SECOND by Commissioner Murphy. The motion carried unanimously.

4) Richardson Community Center - Outdoor Court Lightning

The BOCC approved a Capital Project to install outdoor court lights at the Richardson Community Center. The project was placed on hold until ownership was determined. Since, Columbia County has obtained official ownership of RCC, Staff is requesting permission to move forward with the project.

MOTION by Commissioner Murphy to approve to move forward with the capital project to install outdoor court lights. SECOND by Commissioner Williams. The motion carried unanimously.

5) Renewal of County Group Health Insurance

The final negotiated renewal proposal from Florida Blue reflects a 4.8% decrease in premium.

MOTION by Commissioner Williams to approve final negotiated renewal proposal from Florida Blue of a 4.8% decrease in premium and retain the current plan benefits. SECOND by Commissioner Phillips. The motion carried unanimously.

6) Interlocal Agreement – Medical Examiner Services

Pursuant to Chapter 406, Florida Statutes, the Medical Examiner for District IV provides service to two counties of District III, Columbia County and Hamilton County. This Interlocal Agreement would renew the agreement with the City of Jacksonville for Medical Examiner Services and establishes the rates for these services.

MOTION by Commissioner Williams to approve Interlocal Agreement with the City of Jacksonville for Medical Examiner Services. SECOND by Commissioner Murphy. The motion carried unanimously.

7) BA 23-57 - Federal Forfeiture Funds - \$134,435

The Sheriff has requested \$134,435 from Sheriff's Federal Forfeiture fund to replace service weapons.

MOTION by Commissioner Murphy to approve BA 23-57. SECOND by Commissioner Hollingsworth. The motion carried unanimously.

8) Termination of Interlocal Agreement – Building Official Services

On May 24, 2023, the City of Lake City provided a Notice of Termination for the Interlocal agreement for Building Official Services with a last day of November 20, 2023.

Discussion ensued, no action was taken.

9) 911 Dispatch Consolidation Update

At the May 24, 2023 workshop, the Commissioner Williams requested an update on efforts to consolidate the dispatch of the Sheriff, County Fire, Lake City Police and City Fire Departments under the County PSAP. A meeting will be held on Tuesday May 30 to discuss consolidation, and the results of this meeting will be presented to the Commission.
